#### **Family and Community Dedication**

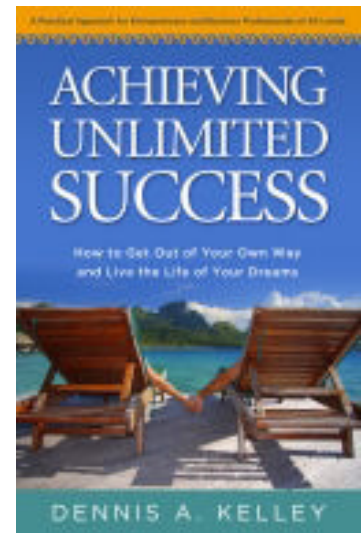
